REPORT STRUCTURE

The Clerical Test Battery assesses your capacity (a composite of speed and accuracy) to perceive logical patterns and relationships in new material you have not previously encountered, and deduce the logical consequences of these (i.e. logical deductive reasoning). This incorporates the ability to: learn and understand complex new material; use logic to develop arguments that are rational and well-reasoned; deduce the logical consequences of a given set of rules, assumptions or relationships.

THE FEEDBACK REPORT

The Feedback Report provides a detailed breakdown of your performance across the sub-scales in the following sections:

- 1. Verbal Reasoning
- 2. Numerical Ability
- 3. Clerical Spelling
- 4. Clerical Checking

VERBAL REASONING

The verbal component of the Clerical Test Battery measures an individual's ability to reason using words, and draw inferences and logical conclusions from them. This includes both an understanding of the meaning of words and the relationships between them.

Compared to the reference group you have performed rather less well than most on the verbal component of this test. This clearly demonstrates a significant weakness in your ability to understand concepts and principles expressed verbally. Consequently, one would expect you to take longer than most in understanding such written material and explanations. While you should be able to understand instructions of a basic nature, more complicated explanations and instructions may be beyond your ability.

NUMERICAL ABILITY

The numerical ability component of the Clerical Test Battery measures the individual's ability to use and manipulate numbers in a logical way. This includes both an understanding of numbers and the relationships between them.

Your score on the arithmetic component of this test falls considerably below the typical range achieved by the reference group. This suggests that you are more likely than most to make mistakes when engaged in figure work or other general duties involving arithmetic computation.

CLERICAL SPELLING

The spelling component of the Clerical Test Battery evaluates the individual's ability to spell commonly misspelt words.

Your score on the test of spelling ability falls considerably below the typical range achieved by the reference group. This suggests that you would generally have difficulty with spelling words correctly; this would be particularly pronounced with those words which are commonly misspelt.

CLERICAL CHECKING

The clerical checking component of the Clerical Test Battery evaluates the individual's ability to perceive details in words and numbers quickly, to recognise likenesses and differences rapidly.

Your score on the clerical checking component of this test falls considerably below the typical range achieved by the reference group, indicating that you are likely to make mistakes when engaged is tasks such as proof reading and the like. As a result, you may have a tendency to overlook typographical errors.
